



a Farm Bureau woman who is
actively engaged in production
agriculture. This award will
recognize, encourage, and reward
the achievements of women farmers.
The recipient will personify the
highest level of professional
excellence in agriculture.



## Entry Guidelines at a Glance

- 1. The individual must be actively involved in farming or an agriculture-related operation.
- 2. Nominees must be a Farm Bureau member.
- Applicants will be judged by a panel of out of state agricultural professionals.
- 4. Nominations must be received by Friday, August 29, 2025.

#### KENTUCKY FARM BUREAU WOMEN'S PROGRAM MISSION

The Kentucky Farm Bureau Women's Program's primary objective is to encourage engagement by providing and coordinating opportunities for women's educational and leadership development; thus, better enabling them to become active participating members of Farm Bureau. Ultimately, women's activities are organized throughout the state for the purpose of implementing Farm Bureau policy goals and objectives.

### KENTUCKY FARM BUREAU FARM WOMAN OF THE YEAR NOMINATION RULES AND GUIDELINES

#### Purpose of this Award:

To recognize a Farm Bureau woman for contributions in the following areas:

- Farm business and productivity
- Farm Bureau engagement and leadership
- Involvement in other agricultural related activities
- Knowledge of agricultural issues
- Community involvement

#### **Eligibility:**

- 1. Must be nominated by a Farm Bureau member.
- 2. The individual must be actively involved in farming or an agriculture-related operation.
- 3. A recent photograph of the nominee along with additional supporting photographs demonstrating the individual's agricultural business, leadership and overall leadership experience are to be included with submission of the application.
- 4. Any Farm Bureau member is eligible to nominate **one** entry for the KFB Farm Woman of the Year. Completed applications must be postmarked by August 29, 2025. Submit signed applications to:

- 5. Applicants will be judged by a panel of out of state agricultural professionals.
- 6. The top applicants will be invited to be interviewed by the judges.
- 7. The state winner will be announced at the Gold Star Luncheon held in conjunction with the KFB State Annual Meeting.
- 8. All Farm Bureau women are eligible except for current members of the following:
  - State Board of Directors or their family members
  - State Women's Advisory Committee
  - State Young Farmer Advisory Committee
  - Generation Bridge Committee

Also, Farm Bureau employees or their family members are excluded from participating.

#### Judging Criteria (100 points maximum)

- Farm business and productivity...... 50 points
- Farm Bureau engagement and leadership......20 points
- Involvement in other agricultural related activities....... 15 points
- Community involvement...... 5 points

Award: \$1,000 cash award along with a plaque of recognition.
